

AL-CO PRODUCTS, INC. "TWO YEAR" LIMITED WARRANTY

For a period of two (2) years from the date of original sale, Al-Co Products, Inc. (Al-Co) warrants its product will be free from defects in materials and workmanship as set forth below. Al-Co will, at its option repair or replace any product which, upon examination, inspection and testing by Al-Co, or its Distributor, is found to be defective. Any product that the purchaser/owner claims to be defective must be returned to and examined by the Distributor from which the product was purchased. All transportation costs, and all costs associated with removing, installing or handling, including return to the Distributor, are to be borne and prepaid by the purchaser/owner. This limited warranty applies only to product manufactured by Al-Co, and is not transferable. This limited warranty is for residential application, and is effective for a period of two (2) years.

CONSUMER APPLICATION

Due to the composition and nature of Al-Co's product, some color and/or veining will vary, and will not be considered a manufacturing defect for purposes of this limited warranty. This limited warranty shall apply only to product placed in its original installation, and shall be void upon any reinstallation made subsequent to its original use.

THIS WARRANTY SHALL NOT APPLY TO THE FOLLOWING:

- Damages caused from exposure to temperatures, from water, curling irons, candles, or otherwise, which are in excess of 120 degrees Fahrenheit.
- Damage caused by the use of abrasives of any nature or kind.
- Damage related to the use of cleaning agents or compounds not specifically recommended for use on cast polymer products.
- Damage caused by the use of on, or spillage upon the product of any form of drain cleaner.
- Damage or breakage caused from physical abuse; or improper techniques used in installation, or removal.
- Damage caused by the spillage upon, or uses of nail polish, nail polish remover, paints, varnishes, lacquers, or any similar compound, upon the surface of the product.
- Failure by the purchaser/owner to comply with the terms of this limited warranty.

THIS LIMITED WARRANTY IS IN PLACE OF ALL OTHER WARRANTIES, EXPRESS, OR IMPLIED. SPECIFICALLY, AL-CO MAKES NO OTHER WARRANTIES AS TO THE MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. Some states do not allow limitations on how long an implied warranty lasts, so the above limitations may not apply to you.

AL-CO'S ONLY LIABILITY SHALL BE THE REPAIR OR REPLACEMENT OF THE AFFECTED PRODUCT AS STATED ABOVE. IN NO EVENT SHALL AL-CO BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES, EVEN IF SUCH DAMAGES ARE A DIRECT RESULT OF AL-CO'S NEGLIGENCE.
